

ORDER

As per orders of the IG/BR/ASR issued vide No. 31370-470/BR-1 dt. 13.10.2013, the Director General of Police, Punjab, Chandigarh vide his office memo No. 13276-376/E-1 (1) dt. 09.10.2018 has issued the final seniority lists of Inspectors (District Cadre) after 20.02.2008 upto 28.01.2015 after considering the objections submitted by Police officials/officers against tentative seniority.
